# The Grand Italy Pillgrimage

#### Day I: U.S.A / Italy

Our spiritual pilgrimage begins as we depart on our flight to Rome. Meals and drinks will be served on board.

#### Day 2: Rome

After arrival in the "Eternal City," we will be met by our local tour manager and take an afternoon tour orientation tour of Rome, including visits to the Trevi Fountain, where a coin thrown over your shoulder will guarantee you another visit to Rome, and the famous Spanish Steps. Then proceed to our centrally located hotel, our home, for the next three nights. **B/D** 

#### Day 3: Rome

This morning we will experience a highlight of our Roman stay, attendance at the Papal Audience at St. Peter's (subject to the Holy Father's schedule). Join thousands of pilgrims from throughout the world to listen to the Holy Father and receive His Blessing. In the afternoon, our sightseeing includes visits to St. Mary Major Basilica, one of the oldest and most important shrines in the world dedicated to the Blessed Virgin Mary, St. John Lateran where we'll see the Holy Stairs, the Old Appian Way, and the Catacombs. **B/D** 

#### Day 4: Rome

A full day of exploring Rome begins with Mass at St. Peter's Basilica, followed by a tour including the Pieta and Adoration Chapel, which our Holy Father opened in 1981. Our guide will take us to visit the Sistine Chapel and the Vatican Museum with its awesome frescoes painted by Michelangelo. This afternoon our sightseeing of Rome includes visits to the Roman Forum, the Colosseum (view from outside), St. Peter in Chains featuring Michelangelo's "Moses," and St. Paul's Outside the Walls. **B/D** 

### Day 5: Rome / San Giovanni Rotondo

We leave the Eternal City to San Giovanni Rotondo, the small town closely associated with the life of Padre Pio. As we leave Rome, we will stop to celebrate Mass in the Shrine of the Divine Love. Visit Pietrelcina, where Padre Pio was born and grew up. In San Giovanni Rotondo, visit the Grotto of St. Michael and the "Home for the Relief of Suffering," a famous charitable work of Padre Pio. See his tomb, cell and confessional, and the old church where he received the stigmata and the Church of Santa Maria Delle Grazie, a newer church. **B/D** 

## <u>Day 6: San Giovanni Rotondo / Lanciano / Assisi</u>

Depart for Lanciano, where there was a Eucharistic Miracle of Jesus that took place. Then, continue through the Umbrian countryside to Assisi, a town that welcomes us in the spirit of St. Francis and St. Claire into its peaceful

interior. **B/D**

#### Day 7: Assisi

This morning we will visit St. Mary of the Angels Basilica, the Porziuncola, the tiny church in the woods where St. Francis began his ministry and where St. Clare began her religious life. Proceed to the Basilica of St. Francis, where the saint lies in rest and the Basilica of St. Clare. For those with the stamina, take a walk-up Monte Subasio to Eremo delle Carceri, the saint's favorite retreat. **B/D** 

#### Day 8: Assisi / Florence

This morning depart Assisi and drive to Siena, home of St. Catherine. Here we'll visit the sanctuary built on her home site and celebrate Mass at the Church of San Domenico, where she lies in rest. Continue driving north through the beautiful Italian countryside to Florence, the Cradle of Italian Renaissance. **B/D** 

#### Day 9: Florence/Venice Mestre

This morning our tour of Florence is an artful experience as we take in the Ponte Vecchio, the Duomo, the Baptistery with its renowned bronze doors, the Galleria Dell 'Academia featuring Michelangelo's statue of "David," Santa Maria Novella Church and Santa Croce Church. We will then depart Florence and drive north to Padua to visit the Basilica of St. Anthony. After Mass we will continue to Venice, one of Italy's most colorful cities. **B/D** 

#### Day 10: Venice Mestre

This morning we'll enjoy a walking tour of Venice, first visiting St. Mark's Square (Piazza San Marco) and St. Mark's Basilica (Basilica di San Marco) which was built to house the remains of St. Mark. Also visit the famous Doges' Palace and "Bridge of Sighs". The balance of the day is free to explore this fascinating city of islands on our own. **B/D** 





**Reservations and Payment:** Please complete the attached Reservation Application and return it with your deposit of \$300.00 per person at the time of booking. The final payment is due 90 days before departure, February 13, 2024.

**Cancellations:** All cancellations must be in writing. Cancellations received after 5 PM Eastern Time or on weekends/holidays will be processed the following business day. The following per-person cancellation charges will apply: If canceled 101 days or more before departure, a \$75.00 administrative fee will be charged. If canceled 100 - 81 days before departure, \$300.00 will be charged. If canceled 80 - 61 days before departure, \$700.00 will be charged. If canceled 60 - 15 days before departure \$1,000.00 will be charged. No refunds will be made within 14 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable. Once airline tickets are issued they are non-refundable, non-transferable, and cannot be used for future travel. Additional cancellation charges may apply depending upon the cancellation terms of our suppliers.

**Refunds:** Subject to the foregoing Cancellation Terms, upon cancellation of travel-related services, all sums paid to Alba's Tours, LLC for such services will be promptly returned to the passenger, provided the passenger is not in violation of any of the terms and conditions previously, clearly and conspicuously disclosed and agreed to by the passenger. This refund provision does not apply where Alba's Tours, LLC has remitted the payment to another registered seller of travel or a carrier and they default in providing the agreed-upon transportation or service without providing a refund. In such a situation, Alba's Tours, LLC agrees to provide passengers with a written statement accompanied by a copy of the bank records establishing the disbursement of the payment, and if disbursed to a seller of travel, proof of their current registration.

**Travel Documents:** A passport with a minimum of 6 months validity is required of all U.S. citizens. If you are not a U.S. citizen, please call to find out if you need a visa. Alba's Tours, LLC is not responsible for individual visas or passports. You must carefully observe all applicable formalities and ensure that the surnames and forenames used when submitting the application correspond exactly with those appearing on your passport, visa, etc.

**Tour Cost:** All quoted prices are based upon airfares, tariffs, and currency exchange rates at the time of printing and are subject to change at any time. Should the minimum number of 20 tour members not be reached, the right is reserved to increase the tour cost accordingly or cancel the tour.
