# Marian Shrines Pillgrimage

#### Day I: U.S.A / France

Our spiritual pilgrimage begins as we depart on our flight to France. Meals and drinks will be served on board.

#### Day 2: Paris / Lourdes

Upon arrival in Pau, we will be welcomed by our expert tour manager and transfer to our hotel in Lourdes, one of the most significant pilgrimage shrines in the world. Here in Lourdes, Our Lady appeared to St. Bernadette in 1858, proclaiming herself the "Immaculate Conception." **B/D** 

#### <u>Day 3: Lourdes</u>

Today, we will have all day to experience the unique, healing atmosphere of this beautiful town. We will attend Mass at the Grotto of Massabielle, where the Virgin appeared. Also, visit the Basilica of Pius X (the world's largest underground church), see the house where Bernadette lived during the Apparitions, and visit several sites where miraculous cures occurred. This evening, we will participate in the Candlelight Procession. **B/D** 

#### <u>Day 4: Lourdes / Loyola / Burgos</u>

We depart from Lourdes and head toward the French-Spanish border crossing for Loyola. We will have a private Mass at the Loyola Sanctuary. Pray at the Basilica where Our Lady with the Christ Child appeared to St. Ignatius, the founder of the Jesuit order. We then will drive to Burgos, the historic city that was the capital city of the unified Kingdom of Castile and Leon for five centuries. It is home to one of the masterpieces of Spanish Gothic architecture with its gorgeous Cathedral, which was declared a UNESCO World Heritage Site. **B/D** 

#### Day 5: Burgos / Segovia / Madrid

This morning, we will enjoy a sightseeing tour of Burgos, including visits to the Arco de Santa Maria, the Old Town, and the striking Gothic Cathedral. Continue to Segovia, where we will visit the extraordinary fairytale Alcazar, the magnificent Cathedral, and the splendid Roman Aqueduct. Every corner of Segovia's casco antiguo sparkles with Romanesque churches and elegant old houses. We will drive to the capital city of Madrid, where we will stay for two nights. **B/D** 

#### <u>Day 6: Madrid</u>

This morning's city tour of Spain's capital, Madrid, will show some of the richest history and traditions of the country. We will begin our day with a visit to the iconic Prado Museum with its masterpieces by El Greco, Goya, and Velasquez. We will then continue our city tour with visits to the Cathedral, the Royal Palace, Puerta del Sol, and the Plaza Mayor. **B/D**

### <u>Day 7: Madrid / Avila / Salamanca</u>

This morning, we will depart Madrid and drive to the stunning medieval walled town of Avila. Several of its many religious buildings are connected with Avila's revered heroine, Saint Teresa de Jesus, who was born there in 1515 and is considered one of the Catholic Church's greatest mystics. We will visit the Convent of St. Teresa, which contains some of the saint's relics, the Monastery of the Incarnation, where she lived and where her cell can be visited, and the Monastery of Saint Joseph, which St. Teresa founded. We will then drive to Alba de Tormes to visit the Carmelite Convent, which contains St. Teresa's incorrupt arm and heart. Then, we proceed to Salamanca, where we will check into our hotel for an overnight stay. **B/D** 

#### <u>Day 8: Salamanca / Santiago de Compostela</u>

This morning, drive to Santiago de Compostela, the reputed burial place of St. James the Great. Tradition tells us that St. James the Apostle journeyed to Spain in 40 A.D. to spread the Gospel as far as possible. He died a martyr's death after returning to Jerusalem, and his remains were eventually returned to Spain and buried in this city. **B/D** 

#### <u>Day 9: Santiago de Compostela / Fatima</u>

This morning, we will enjoy a complete tour of Santiago de Compostela. Visit the impressive Cathedral, which is one of the most prominent pieces of architecture in Europe and the final destination for El Camino. Climb the stairs behind the altar to visit the crypt, where a silver urn contains the relics of St. James. See the Portico de la Gloria (Gateway to Heaven), an unparalleled masterpiece. After Mass, cross the border from Spain to Portugal and proceed to Fatima, one of the world's most important shrines. **B/D** 

#### <u>Day 10: Fatima</u>

Today, we will celebrate Mass on the spot where Our Lady appeared to three children at the Chapel of Apparitions. Visit the Basilica to see the site of Francisco and Jacinta's graves and then to the hamlet of Aljustrel, where the three children lived during the Apparitions. Continue to Valinhos, where Our Lady appeared following the children's release from prison. **B/D**

#### Day II: Fatima / Santarem / Lisbon

We drive south to Santarem for Mass at the Church of St. Stephen, famous for its revered Eucharistic Miracle. Then, go to Lisbon, the birthplace of St. Anthony of Padua (the patron Saint of Portugal). Visit the Lisbon Cathedral and the magnificent Monastery of St. Jeronimo. Transfer to our hotel and enjoy the rest of the day at leisure to explore this colorful capital city of Portuguese tiles on your own. Our farewell dinner will be in a local restaurant. **B/D** 

#### Day 12: Lisbon / U.S.A

Following breakfast, transfer to the airport with the group. Meals and drinks will be served aloft.

**Reservations and Payment:** Please complete the attached Reservation Application and return it with your deposit of \$300.00 per person at the time of booking. The final payment is due 90 days before departure, July 19, 2024.

**Cancellations:** All cancellations must be in writing. Cancellations received after 5 PM Eastern Time or on weekends/holidays will be processed the following business day. The following per-person cancellation charges will apply: If canceled 101 days or more before departure, a \$75.00 administrative fee will be charged. If canceled 100 - 81 days before departure, \$300.00 will be charged. If canceled 80 - 61 days before departure, \$700.00 will be charged. If canceled 60 - 15 days before departure \$1,000.00 will be charged. No refunds will be made within 14 days of departure. In addition, once the airline tickets have been issued, 100% of the airfare is non-refundable. Once airline tickets are issued they are non-refundable, non-transferable, and cannot be used for future travel. Additional cancellation charges may apply depending upon the cancellation terms of our suppliers.
